The Aim of the Event



What was the aim?

The aim of the MRV Autumn School was to empower participants to implement national processes for institutionalising MRV systems and act as multipliers in their countries.

Who took part?

24 practictioners and decision-makers from 23 membership countries to the Partnership

What happened?

The participants attended presentations and exercises and exchanged their experiences and best practices on MRV of emissions, actions and support.

What results were obtained?

Better understanding of MRV on emissions, actions and support with participants, strong bonds created between participants, many action points on MRV taken home by participants.

AND: Discussions during Autumn School referred to during negotiations on domestic MRV guidance for developing countries at COP!


Twenty three countries from the five continents:

What happened?




- Day 1 15 October 2012: MRV requirements and functions

- Day 3 17 October 2012: MRV in systems other than national inventories, e.g. CDM
- Day 4 18 October 2012: MRV for NAMAs
- Day 5 19 October 2012: Excursion to Federal Environment Agency and energy autonomous village Feldheim
- Day 6 21 October 2012: Exercises summarising the training contents of the previous days on biennial update reports (BURs)
- Day 7 22 October 2012: Expectations of climate financing donors and MRV of support
- Day 8 23 October 2012: Exercises/discussions summarising the training contents of the previous days, main findings and evaluation





Good practice for MRV systems

- Clear long-term objective and vision
- Commitment and leadership
- Clear responsibilities
- Robust methodologies
- SMART indicators
- Consideration of national and sectoral circumstances
- Standards for data/ reliable information
- Simplicity
- Participatory processes
- Harnessing existing methodologies and institutions
- Enforcement framework
- Step-by-step development over time

The Results: What Participants took home





- Urgency to start action setting up MRV systems takes time
- Some MRV elements are already in place but under a different name
- Start now with what you have
- Ensure sustainability and ownership of GHG inventory
- Set up a network with other practictioners for mutual support
- Ensure better exchange between negotiations and practitioners
- Ensure ownership and leadership in setting up MRV systems
- Provide more technical capacity building
