- This is a draft framework, based on early thinking by UNDP and WRI
- Many ways to think about how to proceed with implementation
- There is no "right" order for the steps of implementation
- Not all planning and implementation activities will pertain to all countries; depends on (I)NDC and national circumstances
- Mitigation concepts focus on (I)NDCs with economy-wide targets, but many steps the same for non-GHG targets or policies & actions
- Interested in countries' feedback
 - This will contribute to possible development of more detailed guidance (building on last year's guidance document *Designing and Preparing INDCs* and recent **UNDP survey** on support needs)








Colombia's NDC Implementation Planning



- Building awareness and support
 - Conscious effort to secure broad participation
 - Identifying champions in local governments, private sector, etc.
- Institutional arrangements and capacities
 - Inter-ministerial commission to coordinate across ministries
 - "Regionalization" effort: work with local/regional governments and stakeholders
- Technical preparations
 - Building on existing inventories, plans, analyses under LCDS
 - 2016 process of sectoral allocation of national mitigation target (-20% from BAU by 2030)

Trinidad & Tobago's Implementation Plan & Resource Mobilization



- Developing implementation plan
 - Currently developing implementation plan that will identify concrete actions and projects (in consultation with relevant stakeholders)
 - Will build on technical analyses for the development of low-carbon development action plans for the power generation, industry, and transport sectors
- Mobilizing resources
 - Conducting a finance needs analysis (and TNA) for NDC implementation
 - Developing projects that will seek funding from national Green Fund, GCF, GEF, other international sources
 - Designing portfolio of projects to be financed by the national budgetary process through the Public Sector Investment Programme
 - Consistent with national policy and mainstreaming efforts

Monitoring Plan in South Africa



Phase 1 (to end 2016) Setting-up



- » Setting up the legal & regulatory framework
- » M&E system institutional setup
- » Mapping climate monitoring systems & stakeholders
- » Refining adaptation M&E networks
- » Developing MRV guidelines
- » Produce 1st & 2nd annual M&E reports

Phase 2 (2017-18) Operationalization

- » Web-based platform operationalization & training
- » Adoption of standardized MRV methods
- » Testing of adaptation data-sharing networks
- » Learning and documentation of lessons
- » Improvement of annual M&E reports; publication of the 3rd & 4th Annual reports

Phase 3 (2019-20) Refinement & inalization

- » System improvement based on lessons learnt
- » Setting up a fully operational system structure
- » Accuracy, completeness & consistency pursued
- » System outcomes fully integrated into decisionmaking processes
- » Publication of the 5th & 6th annual M&E reports




Amend implementation plan based on observed impacts

Institutionalize planning for future cycles (every 5 yrs)



Plan for future NDCs

Develop or update long-term mitigation strategy (e.g., mid-century LEDS per Paris)

Update NAPs or long-term adaptation planning

Systematically assess additional mitigation and adaptation options

Norway's INDC Planning Based on Long-Term Strategies






Figure 0-3 Possible emission trajectories up to 2050. (M1=mitigation package 1, M3=mitigation package 3)
