Enhanced Transparency Framework after Katowice – support initiatives and country perspectives

Description

Article 13 of the Paris Agreement established an Enhanced Transparency Framework (ETF) for action and support that takes into account Parties' different capacities and builds upon collective experience. Tracking and understanding of the progress of implementations and achievement of climate actions is not only critical to achieving the Paris Agreement goals, but also assisting countries in putting in place effective climate policies, prioritizing areas where actions are most needed and where climate finance would deliver the best outcomes.

At COP24 in Katowice, Parties agreed on Modalities, Procedures and Guidelines (MPGs) for the Enhanced Transparency Framework. The MPGs are applicable to all Parties to the Paris Agreement with flexibility to those developing countries that need it in the light of their capacities. The first reports under the enhanced transparency framework will be submitted by Parties by no later than 31 December 2024.

This session aims to socialize the COP 24 outcomes on the enhanced transparency framework and highlight key implications on the institutional arrangements. The session will also touch on challenges and opportunities in accessing international support to developing countries to implement the existing MRV arrangements and transition to the enhanced transparency framework under the Paris Agreement.

Objective

With the MPGs, countries will need to consider the status of the national system for measurement, reporting, and verification (MRV) and the extent to which they might need to be updated and improved to meet the ETF requirements. Therefore, it is important to discuss the latest developments and share experience from the region, also in the light of international opportunities to support the establishment and consolidation of the MRV system. The main objectives are:

- Familiarise countries with the new MPGs for transparency and the implications for national implementation;
- Illustrate capacity building initiatives on transparency;
- Discuss challenges and experiences from the countries with the support received for establishing MRV systems;
- Identify options for future improved planning of international support to achieve tangible results.

The session is divided into two parts.
